The 8th International CMI Conference will take place November 26-27, 2015 at Center for Communication, Media and Information Studies at Aalborg University, Copenhagen, Denmark.



The CMI Conference bridges academia, industry, and government to explore cyber security trends, threats and solutions for society.

### About the conference

Cyber security is a global issue with local impact. When cyber security breaches occur, it impacts on society at all levels: Users lose trust in digital platforms, companies lose money, and public institutions are discredited.

Most conferences on cybersecurity focus on industry and government perspectives. The CMI Conference brings an academic and socio-technical approach: it identifies the issues across domains, examines user perspectives, and provides critical analysis on factors that may inhibit cyber security solutions. Aalborg University's International Economic Crime and Cybercrime Research Centre (IECC) will provide insight on the optimal application of law enforcement.

To facilitate discussions between academia, industry and government on cyber security

To discuss trends, threats and solutions for cyber security, privacy and cyber-crime from individual, organisational, public, and market perspectives

Papers will be peer-reviewed and a selection will be published in a special edition of the *Nordic Baltic Journal of ICT* (Electronic publication, ISBN 1902-0988) (find

Full papers must be no more than 12 pages. Papers must be submitted in either PDF, .DOC or .DOCX format. Submit abstracts and full papers should to Lene Sørensen ([ls@cmi.aau.dk](mailto:ls@cmi.aau.dk)) clearly indicating the name of the contribution, author and affiliation..

Authors of accepted papers will have an opportunity to present at the conference.

September 7, 2015: Notification on acceptance of abstracts

October 12, 2015: Full paper (maximum 12 pages)

November 3, 2015: Peer review of full papers

November 20, 2015: Camera-ready submission of full papers

If extended abstracts are being accepted they are guaranteed presentation on the conference when a full paper is delivered. All full paper contributions will be reviewed. All accepted papers will be published in the CMI Conference Repository. At least one author of a paper should register to have the paper presented at the conference.
